- viii) NOC from the present employer, if the candidate presently employed in Govt. Depts./Govt. Organizations/PSUs/Autonomous Organizations.
- 2. Mere provisionally short-listing for the Personal Interview shall not automatically make an applicant eligible for recruitment. If a candidate fails/unable to submit any of the above mentioned documents, the candidature of the candidate will not be considered for recruitment.
