No.CI.187/2012/Pt-III/230:- In exercise of the power conferred under the provision of clause 10.6(iii) read with 10.6(i) of the Industrial & Investment Policy of Assam, 2014, the Governor of Assam is pleased to make an amendment in Annexure-1 titled "**List of non-eligible activities**" of the Industrial & Investment Policy of Assam, 2014 and incorporate the following additional activities in the List of non-eligible activities for incentives under the Policy after item No.6 "Coke".

7. The activities, which are not treated as manufacture as per Rule 57A of the Assam VAT Rules, 2005, as specified below:

- (a) Saw mill,
- (b) Tea Industry,
- (c) Galvanization, corrugation of sheet or both,
- (d) Marble and decorative stone cutting from slabs/sheets and polishing unit,
- (e) Paper cutting from roll paper,
- (f) Coal to washed coal, sized coal,
- (g) Conversion of plain rod to tor rod,
- (h) Refining and packaging of mustard oil,
- (i) Refining of engine oil,
- (j) Purification and/or packaging of drinking water,
- (k) Production of cooked food, sweet meats and namkins, if the investment in plant and machinery in a unit is less than rupees five crores,
- (l) Conversion of coal to coke.
