



- c) The rates should be quoted after visiting the site and taking into account the site condition.
- d) The Bidder, at the Bidder's own responsibility and risk is encouraged to visit and examine site of works and its surroundings and obtain all information that may be necessary for design and preparation of the Bid. The cost of visiting the site shall be at the Bidder's own expense.
- e) Taxes, as applicable under state and central Govt. norms will be deducted from the bills as per rules.
